It provides microfinance and consumer finance to entrepreneurs and small and medium-sized enterprises with small and fast credit and loans in China. It has operation centers in Shenzhen and Guangzhou with service network across China.

Shanghai WeXFin is a company incorporated in China, which developed and operates www.weicaifu.com (“**Weicaifu**”). It provides services of release and management of investment information, transaction management and transaction funds settlement of investment and financing products to its customers.

Taiping General Insurance Ningbo Branch is an insurance company incorporated in China, its primary business covers insurance business in property loss insurance, liability insurance, credit insurance and guarantee insurance in RMB or foreign currency; short-term health insurance and accident injury insurance business, reinsurance business of various kinds of property insurance, service and consultancy of various kinds of property insurance and its reinsurance, as agent of other insurance companies in respect of related business, capital management business permitted by China laws and regulations and other business approved by China insurance regulators.
